**YOU HAVE JUST RECEIVED A TICKET " WHAT DO I DO NOW ? "
READ THESE INSTRUCTIONS**

IF YOU ARE UNDER AGE 18 YOU HAVE TO COME TO COURT ON ANY VIOLATION

WARNING TO ALL PERSONS UNDER 18 YEARS OF AGE:

YOU MUST APPEAR IN COURT WITH A PARENT OR LEGAL GUARDIAN. If you fail to appear for any court appearance or fail to comply with any court order, the court will direct the Arizona Motor Vehicle Division to suspend your driver's license or driving privilege until you have satisfied the court, or until your eighteenth birthday.

YOU MAY TAKE CARE OF YOUR CIVIL TRAFFIC VIOLATION BY MAIL OR IN PERSON AT THE COURT CLERK'S OFFICE ON OR BEFORE THE APPEARANCE DATE ON YOUR TICKET.

SELECT ONE OF THE OPTIONS BELOW

IF YOU FAIL TO RESPOND BY YOUR APPEARANCE DATE: A default judgment will be entered against you, a fine will be imposed plus a \$20.00 late or time payment fee. **Your driver's license will be suspended** until the entire fine is paid.

Check One

A. I DON'T WANT TO COME TO COURT! Just let me pay and forget it.

"I plea responsible and waive my right to trial and consent to the judgment and sentence imposing the prescribed fine." I am enclosing the Fine/Bond amount as indicated on the bond schedule for EACH violation.

B. I WANT A HEARING! "I PLEA NOT RESPONSIBLE" and REQUEST A HEARING.

I am enclosing the Fine/Bond amount as indicated on the bond schedule for EACH violation.

I understand that: If I fail to appear at the hearing, a default judgment will be entered against me and my deposit will be used to satisfy the judgment, the Motor Vehicle Dept. will be notified. I waive my right to be represented by counsel if I do not notify the court in writing at least 10 days prior to the hearing date. The court will set a hearing date and time and notify you and the officer. *Note: Setting a hearing will result in the loss of your option to attend a defensive driving class.*

C. I WANT TO ATTEND DEFENSIVE DRIVING SCHOOL AND HAVE THE VIOLATION DISMISSED

1. I understand that I may attend defensive driving school for **only one** (1) eligible violation.

2. I understand that I must complete the course within 30 days.

3. I have not attended defensive driving school in the last two (2) years.

4. My violation (28-_____) is eligible as indicated by an * on the Bond/Fine schedule on the other side.

5. I must schedule myself for school by calling: (before my appearance date)

Locally in Kearny or Superior (1-928-425-6738) Within the State (1-800-347-6874) or (1-800-293-0112)

6. **I must call the court:** (520) 363-7752 and notify the Clerk of my schedule.

7. Send no money for the violation you attend school for.

8. On completion. This Violation will be dismissed, I will owe no fine, I will receive no points on my license.

HOW TO FIND THE BOND/FINE AMOUNT

NOTE: IF YOU ARE ATTENDING DEFENSIVE DRIVING SCHOOL DO NOT SEND ANY MONEY TO THE COURT FOR THAT VIOLATION

- Look at YOUR TICKET beside the letter "A" for the section number. Enter that violation code (example 28-701a) in the "Section" column.
- Find the same section number on the BOND/FINE SCHEDULE above and enter that amount in the Bond/Fine column.
- Repeat for any other violation on your ticket (B,C,D,E).
